Our Emergency shelter program provides shelter along with supportive services such as therapy and case management to individuals and families who are survivors of domestic abuse and their children. In fiscal year 2023-2024, the emergency shelter provided 13,152 shelter bed nights for 253 individuals/families which includes 72 children.

The Victim advocate program provides support and services for domestic abuse survivors who are experiencing court proceedings due to abuse. Our advocates provide court accompaniment, assistance writing impact statements for court, orders of protection, general lay legal advocacy, and safety planning. In FY 2023-2024, 250 people were served in this program.

Our Outpatient counseling program provides therapy for individuals and children who are experiencing or have experienced domestic abuse. In FY 2023-2024 fiscal year, our counseling program served 372 people including 33 children.

In FY 2023-2024, 90 new offenders began treatment.

Transitional housing provides up to two years of safe housing for individuals and families leaving abusive relationships and environments. It provides intensive case management for those who are working and/or attending an education program. The goal of this program is to help families obtain and maintain self-sufficiency. In FY 2023-2024, this program served 67 individuals including 46 children which totaled 11,212 bed nights.
